In exercise of the powers conferred by clause (a) of Sub - section (1) of Section 32 of the Indian Veterinary Council Act, 1984, read with the Rule 3 of the West Bengal Veterinary Council Rule, 1999 regarding procedure of Election under Caption "Election" of part II of the West Bengal Veterinary Council Rules 1999, it is hereby notified that a General Election for electing four members of West Bengal Veterinary Council will shortly be held. The Draft Electoral Roll will also be published soon for the purpose of this Election.

Soon after this notification is issued the Registrar of the West Bengal Veterinary Council shall prepare in Form I the Roll which shall contain the names of the persons whose names are entered in the State Veterinary Register and the names of the Electors shall be arranged in the order in which they are entered in the State Veterinary Register.

Now, the Draft Electoral Roll so prepared under Rule 4 of the West Bengal Veterinary Council Rules, 1999 shall be published by the Registrar on 29th August, 2016 at 10 A. M. by displaying along with a notice in Form - II and enclosing specimens of Form III & IV in the Office of the State Council at 37, Kshudiyam Bose Sarani, Kolkata-700037 and each of the offices of the Deputy Director, A. R. D. of the district of West Bengal. Every claim in Form III for inclusion of a name duly signed by the person who requires his name to be included in the Roll and every objection in Form - IV to an entry therein shall be preferred by a person whose name is already included in the Roll being countersigned by another person whose name is also included in the Roll, within a period from 29th August, 2016 10.00A.M to 27.th September, 2016 up to 5.30 P.M. Such claims and objections, as the case may be, shall be examined by the Registrar keeping a record of remarks thereon and either be allowed or rejected provided that a claim or objection shall not be rejected by the Registrar unless the person making it, is given an opportunity of being heard.

For the purpose of final publication of the Roll, the Registrar shall, after disposing of the claims and objections, if any, prepare a list of amendments in Form - V to carry out his decisions and to correct errors, clerical or printing, whatsoever and other inaccuracies in the Roll subsequently discovered or brought to his notice. Thereafter, the Registrar

shall publish the Roll with a notice in Form VI together with the list of amendments by making a complete copy thereof available for inspection by displaying it on the 10th November, 2016 at the Office of the State Council. Now, the Roll together with the list of amendments!, on such final publication, shall be the Electoral Roll of persons who may elect the members of the State/Council as enjoyed in clause (a) of Sub - section (1) under section 32 of the Act. A copy of the final Electoral roll together with the list of amendments published under Sub-rule 2 of Rule 8 of the West Bengal Veterinary Council Rules, 1999 shall be sent by the Registrar to the State Government.
