NOTIFICATION

WHEREAS, as per sub rule 2 of rule 16 of the West Bengal Veterinary Council Rules, 1999, the declaration paper in Form XI has to be numbered but the said Form XI appended to the Rules does not have any provision of numbering;

AND WHEREAS, as per sub rule 8 of rule 16 of the West Bengal Veterinary Council Rules, 1999, the outer envelope containing ballot paper kept in the inner envelope should be submitted by post at the elector's own cost or by hand to the Returning Officer but there is no provision in the rule for identifying that the elector is submitting the said outer envelope by hand in person;

AND WHEREAS, it transpires from clause 4 of the Form X of the West Bengal Veterinary Council Rules, 1999 that "the elector shall not affix his signature or give any other mark of his identity on the ballot paper or on the cover in Form XIII". However, in Form XIII there is a provision of "Signature of the Elector";

NOW THEREFORE, the Governor is pleased to direct that (i) the provision for numbering may be incorporated in the Form XI of the West Bengal Veterinary Council Rules, 1999, (ii) the provision for Serial Number on the outer envelope containing ballot paper may be incorporated to identify that the elector is submitting the outer envelope, containing ballot paper kept in the inner envelope, by hand in person and (iii) the provision of "Signature of the Elector" in Form XIII may be deleted.

The amendment of the West Bengal Veterinary Council Rules, 1999 to this effect will be done following the due procedure of law as soon as possible.

The Returning Officer for election of West Bengal Veterinary Council Election-2017 is requested to intimate each member of the West Bengal Veterinary Council regarding this notification and take further necessary action accordingly.

This notification shall come into force immediately and shall remain into force until further orders or amendment of the West Bengal Veterinary Council Rules, 1999 whichever is earlier.
